### Big Blue Invitational Fishing Tournament

**Eunice City Lake** 

- Cash prizes for the biggest 5 bass and the biggest 10 sac-a-lait stringers. (These are separate divisions but anglers/teams may compete in one or both divisions)
- \$200 entry fee per boat (Maximum of 2 fishermen per boat)
- Teams can also enter the big bass and big sac-a-lait contests for \$25 per contest (only one big bass and one big sac-a-lait will be weighed per team/boat)
- Lunch and a drink will be provided.
- After the weigh-in, participants are encouraged to gather at the Eunice Country Club with alumni and friends who will be taking part in the St. Edmund Golf Tournament that day.
- This tournament is for St. Edmund alumni and friends and will have a 20 BOAT LIMIT
- The Purpose of the Big Blue Invitational is to promote fellowship and camaraderie amongst St. Edmund alumni and friends. We hope that this event will foster Unity, Cooperation and Kindness as we celebrate St. Edmund and Louisiana Sportsmanship.

#### RULES

- 5 fish per team for bass and 10 fish per team for sac-a-lait at weigh-in (separate cash prizes for each division)
- Fishing hours:
  - Start Time 6:30am no boats may depart from launch prior to 6:30am
  - Stop Time 12:30pm (fishing after 12:30pm will result in disqualification)
- Weigh-in will start promptly at 12:45pm (all teams must notify tournament officials when they arrive at weigh-in late arrivals will be disqualified)
- Bass must be at least 12 inches long. Sac-a-lait must be at least 8 inches long.
- THIS IS A CATCH AND RELEASE TOURNAMENT All bass must be alive at weigh-in and released back into Eunice City Lake. (For each dead bass the team will receive a 4 oz. deduction. Dead fish must be iced. There will be no deduction for sac-a-lait that are put on ice but we encourage catch and release for sac-a-lait)
- ARTIFICIAL BAIT ONLY NO SHINERS or LIVE BAIT (crappie nibbles will be allowed)
- In the event of a tie, the stringer with the largest fish for that division will decide the winner (Disagreements or discrepancies will be resolved by tournament officials)
- Any minor (under 18) who participates, must have a parent or guardian sign the attached permission and release form prior to the tournament. Minors must abide by fishing, boating and all other applicable laws.
- Teams must comply with all State fishing and boating regulations (i.e. boater safety requirements for minors and those born after January 1, 1984), including the use of PFD's. State fishing and boating regulations supersede tournament rules. Violation of State law or Eunice City Lake Rules are grounds for disqualification. NOTE: Eunice City Lake has a NO WAKE/IDLE SPEED ONLY rule for the ENTIRE lake. This rule will be strictly enforced.
- NO GUIDES OR PROFESSONAL ANGLERS WILL BE ALLOWED!!
